Dear Representatives MacArthur, Kuster, Fitzpatrick, and Norcross:

On behalf of the Physician Assistant Education Association (PAEA), we are writing to express appreciation for your leadership in addressing the opioid epidemic through the Bipartisan Heroin Task Force's support of the Addiction Treatment Access Improvement Act in the House. PAEA represents the 229 accredited PA education programs in the United States, which collectively graduate more than 8,000 PAs each year. As the opioid epidemic continues to ravage communities across our country, we and our member programs are acutely aware of the pivotal role that PAs in training will ultimately play in stemming the tide of this national crisis.

As you are undoubtedly aware, the CDC estimates that more than 64,000 people died in 2016 due to drug overdoses, with 42,249 succumbing to opioids. The depth of this epidemic clearly illustrates the need for rapidly expanded treatment capacity within a comprehensive public health strategy. The Addiction Treatment Access Improvement Act would build upon the improved capacity of PAs to provide medication-assisted treatment (MAT) as provided for by the Comprehensive Addiction and Recovery Act of 2016 (CARA).
